**WHEREAS THE AUTHORITY** has become inactive for a number of years and has no active members thereon;




**WHEREAS**, it would be in the best interest of the taxpayers of Rush Township to terminate the Authority.


1. The Rush Township Sewer Authority will be dissolved and terminated immediately upon enactment hereof.
