RESOLUTION NO. 99-2

RESOLUTION SETTING GARBAGE COLLECTION AND DISPOSAL FEE

The undersigned, BOARD OF SUPERVISORS OF RUSH TOWNSHIP, SCHUYLKILL COUNTY, hereby certify that at a meeting held on the 4th day of January, 1999, the Rush Township Board of Supervisors unanimously adopted the following Resolution:

RESOLVED, that the Rush Township Board of Supervisors hereby set a garbage collection and disposal fee at \$6.66 per month, to be collected one time annually in one annual payment of \$80.00 to be made by the end of the penalty period on the tax bills sent by Rush Township. In the event that payment is not made as aforesaid, a \$ 20.00 penalty shall be assessed against the nonpaying party. If the bill remains unpaid for an additional 30 days, garbage collection for the nonpaying party shall cease.

The Township Tax Collector is hereby authorized to send out the said garbage fee bills, collect and deposit said monies pursuant to appropriate agreement negotiated between the Rush Township Board of Supervisors and the Township Tax Collector, which agreement would contain provisions concerning bonding and fees charged by the Tax Collector.

Residents shall be limited to five (5) garbage bags per pickup and one (1) large item, not to include tires, batteries, motor oil, or "white" appliances and shall be subject to other such regulations of the Township as they shall from time to time be amended.

I hereby certify that the above Resolution is in full force and effect commencing the 4th day of January.

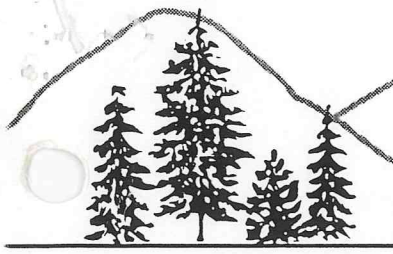

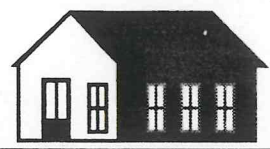

- VI. The Applicant or Subdivider fees listed in Sections I and IV shall be collected by Richard C. Hester. All fees listed in Sections I and IV shall be turn into the Township once a month with the Activity Report.
- VII. The Applicant shall pay the Township the cost for services rendered by Richard C. Hester, as listed in Sections I and IV. The total cost of all services provided under Sections I and IV, shall be paid by the Township to Richard C. Hester, within 30 days after receipt of the monthly Activity Report illustrating all Sewage Enforcement activities.
- VIII. Richard C. Hester shall complete the State Reimbursement forms for the **Township of Rush**, at the end of each calendar year.
- IX. All Resolutions and parts of Resolutions inconsistent with the Resolution are hereby superseded.

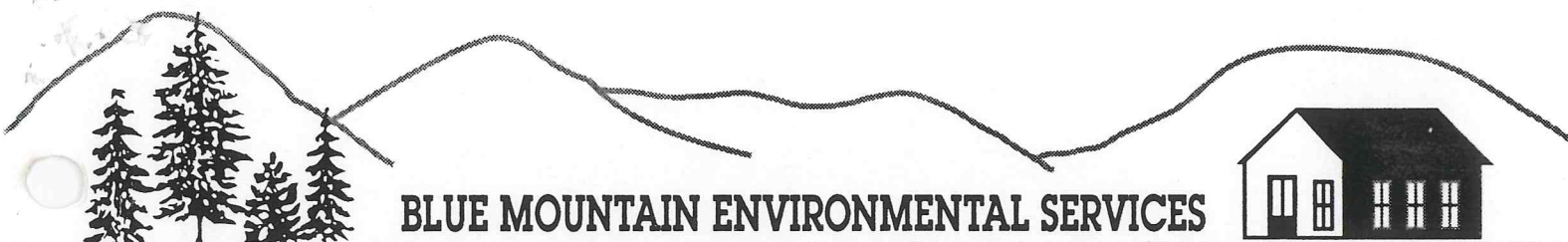
