RUSH TOWNSHIP RESOLUTION NO. 2001 - 02 RESOLUTION SETTING GARBAGE COLLECTION AND DISPOSAL FEES

The undersigned, BOARD OF SUPERVISORS OF RUSH TOWNSHIP, SCHUYLKILL COUNTY, hereby certify that at a meeting held on the 2nd day of January 2001, the Rush Township Board of Supervisors unanimously adopted the following Resolution:

RESOLVED, that the Rush Township Board of Supervisors hereby set a garbage collection and disposal fee at a \$6.66 per month, to be collected one time annually in one payment of \$80.00 to be made by the end of the face period on the tax bills sent by Rush Township. In the event that payment is not made as aforesaid, a \$20.00 penalty shall be assessed against the nonpaying party. If the bill remains unpaid for an additional 30 days, garbage collection for the nonpaying party shall cease.

The Township Tax Collector is hereby authorized to send out the said garbage fee bills, collect and deposit said monies pursuant to appropriate agreement negotiated between the Rush Township Tax Collector, which agreement would contain provisions concerning bonding and fees charged by the Tax Collector.

Residents shall be limited to five (5) garbage bags per pickup and one (1) large item, not to include tires, batteries, motor oil, or "white" appliances and shall be subject to other such regulations of the Township as they shall from time to time amend.

I hereby certify that the above Resolution is in full force and effect commencing the 1st day of January 2001.

- 12. Please note that the above fees do not include the digging of the 7' soil probe pit, the individual percolation test holes or initial pre-soak (8 to 24 hours prior to testing). The percolation test site must be accessible by two-wheel drive vehicle to within fifty feet.
- 13. Fees must be paid in full prior to release of permits/test results.
