A RESOLUTION OF THE TOWNSHIP OF RUSH COUNTY OF SCHUYLKILL, COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING THE FEE STRUCTURE FOR SEWAGE ENFORCEMENT WORK AND SEWAGE PERMITS AND THE APPOINTMENT OF SEWAGE ENFORCEMENT OFFICERS WITHIN THE TOWNSHIP OF RUSH.

The Board of Supervisors of the Township of Rush, Schuylkill County, Pennsylvania, hereby resolve that the following fees for service indicated, see Attachments, (Attachment 1 is for Primary SEO and Attachment 2 is for Alternate SEO) are hereby established and are to remain in full force and effect until such time as the Township, by subsequent resolution, may adopt a new additional schedule of fees and costs.

WHEREAS, the Township recognized the need to appoint and update the listing of sewage Enforcement Officers for the Township: and





RE: Sewage Enforcement Officer Rates - 2004

The following are the Sewage Enforcement Officer rates for the above referenced calendar year.

New Permit: \$500.00 Total Fee - Applicant to pay fee of \$250.00
Township to pay fee of \$250.00 (This fee is reimbursed
by DEP to the township)

Repair Permit: \$250.00 Total Fee - Applicant to pay fee of \$125.00
Township to pay fee of \$125.00 (This fee is reimbursed
by DEP to the township)

Subdivision: Monies are paid by subdivider to the municipality.

- Observe probe - \$40.00 per hour
- Conduct probe - \$50.00 per probe
- Observe perc - \$40.00 per hour
- Conduct perc - \$150.00 per perc
- Review Subdivision Module - \$80.00 per module

All other authorized Sewage Enforcement Officer related work, i.e., malfunction investigation, hearings, etc. are billed at \$40.00 per hour.

Note: No excavation or digging is included in the above rates.

8. **Repair Permits** \$ 115.00

9. All Commercial, Business, Multi-Family Units and Subdivisions shall be billed a fee of \$43.50Per/Hr.

10. All work not covered in the above will be billed at a fee of \$ 43.50 Per/Hr.

11. Application for any system must include a completed PADEP application. The minimum fee of \$ 98.00, payable to Rush Township, must accompany all applications. Payment of fees shall be made by Certified Check, Money Order or equal to the Sewage Enforcement Officer payable to Rush Township.

12. Please note that the above fees do not include the digging of the 7' soil probe pit, the individual percolation test holes or initial pre-soak (8 to 24 hours prior to testing). The percolation test site must be accessible by two-wheel drive vehicle to within fifty feet.

13. Fees must be paid in full prior to release of permits/test results.
