**A RESOLUTION OF THE TOWNSHIP OF RUSH,  
COUNTY OF SCHUYLKILL, PENNSYLVANIA**

**APPROVING THE TRANSFER OF LIQUOR  
LICENSE NO. R-12262 and LID-15427 INTO RUSH TOWNSHIP**

**WHEREAS**, Section 461 of the Pennsylvania Liquor Code authorizes the Pennsylvania Liquor Control Board to approve the transfer of liquor licenses across municipal boundaries within the same county; and

**WHEREAS**, municipalities receiving a new license must issue a resolution approving the inter-municipal transfer of the liquor license from outside the receiving township to within its borders prior to submission of an application for such transfer to the Pennsylvania Liquor Control Board; and

**WHEREAS**, the Liquor Code stipulates that, prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting interested parties to state their concerns regarding the transfer of liquor license into the receiving municipality.

**NOW, THEREFORE, BE IT RESOLVED**, that Zachary M. Zancofsky, has properly requested the approval of the Board of Supervisors of Rush Township for the proposed transfer of Pennsylvania Liquor License No. R-12262 and LID-15427, held by Madeline Butala T/A Butala's Bar of McAdoo, Schuylkill County, PA, to Zachary M. Zancofsky at 339 Claremont Avenue, Tamaqua, Rush Township, Schuylkill County, Pennsylvania; and

**BE IT FURTHER RESOLVED** that the Board of Supervisors of Rush Township has held a properly advertised public hearing on March 15, 2012, pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer; after consideration of the issues, finds that the transfer of Liquor License No. R-12262 and LID-15427 into Rush Township to Zachary M. Zancofsky would not be detrimental to the health, welfare, peace or morals of Rush Township or its residents; and

**BE IT FURTHER RESOLVED**, that the Township of Rush Board of Supervisors has held a properly advertised public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer; and

**BE IT FURTHER RESOLVED**, that Rush Township approves, by adoption of and for the reasons stated in this Resolution, the proposed transfer of Liquor License No. R-12262 and LID-15427 into Rush Township; and

**BE IT FURTHER RESOLVED**, that the transfer of liquor license contemplated hereby is subject to approval by the Pennsylvania Liquor Control Board.

Zancofsky, has properly requested the approval of the Board of Supervisors of Rush Township for the proposed transfer of Pennsylvania Liquor License No. R-12262 and LID-15427, held by Butala's Bar of McAdoo, Schuylkill County, PA, to Zachary M. Zancofsky at 339 Claremont Avenue, Tamaqua, Rush Township, Schuylkill County, Pennsylvania; and

**BE IT FURTHER RESOLVED** that the Board of Supervisors of Rush Township has held a public hearing on March 15, 2012, and had previously given public notice thereof to receive comments on the proposed liquor license transfer and, after consideration of the issues, finds that the transfer of Liquor License No. R-12262 and LID-15427 into Rush Township to Zachary M. Zancofsky would not be detrimental to the health, welfare, peace or morals of Rush Township or its residents; and

**BE IT FURTHER RESOLVED** that Rush Township approves, by adoption of and for the reasons stated in this Resolution, the proposed transfer of Liquor License No. R-12262 and LID-15427 into Rush Township; and

**BE IT FURTHER RESOLVED** that the transfer of liquor license contemplated hereby is subject to approval by the Pennsylvania Liquor Control Board.
