

ORDINANCE #21

AN ORDINANCE laying out, adopting, naming and taking over certain streets and roads in the Frederickson Addition to the Village of Hometown in Rush Township; fixing the lengths, widths and termini thereof, and ordaining the same to be Township Roads.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Rush Township, Schuylkill County, Pennsylvania, in accordance with the provisions of the Act of 1947, PL-1481, Section 15 &c., (53-PS-66-101) as amended, and it is hereby enacted and ordained as follows:

SECTION I: The following streets or roads are hereby laid out, opened, adopted, taken over, ordained and named as follows:

1. SUNSET AVENUE from its intersection with Route #54 Southwardly to Charles Street, being a street forty (40') feet in width and one hundred seventy-five (175') feet in length.
2. SHAWN AVENUE from its intersection with Route \$54 Southwardly to Charles Street being a street forty (40') feet in width and two hundred (200') feet in length.
3. CHARLES STREET from its intersection with Sunset Avenue Eastwardly to its intersection with Shawn Avenue, being a street thirty-five (35') feet in width and seven hundred sixty-five (765') feet in length.

SECTION II: The provisions of this ordinance shall be severable, and if any of the provisions or any part of any provision shall be held to be unconstitutional, illegal or invalid, such decision shall not affect the validity of the remaining provisions of this ordinance. It is hereby declared to be the legislative intent that this ordinance would have been adopted if such unconstitutional, illegal or invalid provision had not been included herein.

SECTION III: All ordinances or parts of ordinances inconsistent with any of the provisions of this ordinance are hereby repealed.

TO: THE BOARD OF SUPERVISORS OF

b. SHAWN AVENUE from its intersection with Route #54 Southwardly to Charles Street being a street forty (40) feet in width and two hundred (200) feet in length.

c. CHARLES STREET from its intersection with Sunset Avenue Eastwardly to its intersection with Shawn Avenue, being a street thirty-five (35) feet in width and seven hundred sixty-five (765) feet in length.
