WHEREAS the said Petition has been entered to No. 3 Miscellaneous March Sessions, 1968, in the Office of the Clerk of the
Courts of Schuylkill County, and

WHEREAS the Court of Quarter Sessions by it's Order has authorized and empowered the BOARD OF SUPERVISORS OF RUSH TOWNSHIP,

Schuylkill County, to reconvey the said real estate to the QUAKAKE VOLUNTEER FIRE COMPANY, free and clear of any public right, and the said Order has authorized the conveyance to be made by ordinance;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED as follows:

1. The BOARD OF SUPERVISORS OF RUSH TOWNSHIP, Schuylkill County, Pennsylvania, has granted, bargained, sold, aliened and confirmed, and does hereby grant, bargain, sell, alien and confirm unto the QUAKAKE VOLUNTEER FIRE COMPANY, INCORPORATED, a Pennsylvania non-profit corporation with its office or principal place of business situate in the Village of Quakake, Rush Township, Schuylkill County, Pennsylvania,

ALL THAT CERTAIN LOT or piece of ground situate in the Village of Quakake, Rush Township, Schuylkill County, Pennsylvania, bounded and described as follows, to wit:

BEGINNING at an iron pin at the intersection of the property lines at the southeast corner of two public streets known as Second and Walnut Streets; thence along said Second Street north seventy seven degrees thirty minutes (77° 30°) east fifty (50°) feet to an iron pin; thence along other lot of Quakake Volunteer Fire Company south eleven (11°) degrees fifty five (55) minutes East one hundred fifty (150°) feet to an iron pin on the north side of a private alley; thence along said alley south seventy seven (77°) degrees thirty (30) minutes west fifty (50°) feet to an iron pin on the east side of said Walnut Street, thence along said Walnut Street north eleven (11°) degrees fifty five (55) minutes west one hundred fifty (150°) feet to the place of beginning.

- 3. All ordinances or part of ordinances inconsistent herewith are hereby repealed.

- 4. That the provisions of The Second Class Township Code; Article VII, Section 701, as Amended, provides that the Township Super-visors with the prior approval of the Court of Quarter Sessions, may reconvey real estate to the original owners, by ordinance, free and clear of any public right.
