ORDINANCE NO. 34

AN ORDINANCE enacted pursuant to the Second Class Township Code creating a Recreation Board to be known as THE RUSH TOWN-SHIP RECREATION BOARD: naming the original members of the Board; fixing their term of office and outlining the powers of said Board.

BE IT ENACTED AND ORDAINED by the Rush Township Board of Supervisors:

- 1. In accordance with the provisions of Article XIX, Section 1902 of the Second Class Township Code, as amended (53 P.S. 66902) there is hereby created a Board to be known as THE RUSH TOWN-SHIP RECREATION BOARD which shall consist of SEVEN (7) members, who shall serve without pay.
- 2. The initial members and their term of office are as follows:

All appointments to the Board after the expiration of the initial term shall be for a period of FIVE (5) YEARS or until their successors are appointed. Members shall be residents of Rush Township, Schuylkill County, Pennsylvania.

- 3. Powers: The RECREATION BOARD OF RUSH TOWNSHIP shall have the power and authority to equip, supervise, operate and maintain parks, recreation areas and facilities within the Township; they shall elect their own chairman and secretary, who shall be a member of the Board, and other necessary officers who shall serve for a term of ONE (1) YEAR: they shall have the power to adopt rules and regulations for the conduct of all business within their jurisdiction, including the right to select, employ and discharge all recreation personnel.
- 4. The Board shall submit an annual report to the Board of Supervisors which shall include an analysis of the community recreation facilities, areas and leadership, giving particular reference to the extent and adequacy of the program, and its effectiveness in view of the public expenditure involved and the public needs to be met.
- 5. All ordinances, or parts of ordinances inconsistent herewith are specifically repealed.
- 6. Constitutionality: Should any part or parts of this Ordinance be declared unconstitutional by any Court of Competent Jurisdiction, it is hereby declared to be the specific legislative intent of the Board of Supervisors that the remaining portions of this Ordinance would have been enacted had the unlawful or uncon-

stitutional provision or provisions not been included in this Ordinance.
