ORDINANCE No. 49

AN ORDINANCE REQUIRING PERMITS FOR THE INSTALLATION OF SEWAGE DISPOSAL SYSTEMS, ESTABLISHING FEES THEREFOR AND PROVIDING PENALTIES FOR VIOLATIONS.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of The Township of Rush, Schuylkill County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same, as follows:

Section 1. That no person shall install an individual or community sewage disposal system or construct any building in the Township of Rush, Schuylkill County, Pennsylvania, in which an individual or community sewage disposal system is to be installed, or make repairs to any sewage disposal system, without first obtaining a permit indicating that the site, plans and specifications of such system are in compliance with Act No. 537, entitled "Pennsylvania Sewage Facilities Act," its supplements and amendments, and the rules and regulations adopted pursuant to said Act No. 537, its supplements and amendments.

Section 2. The following fees for the services indicated are hereby established, said Schedule of Fees to remain in force and effect until such time as the Township, by Resolution, may adopt a new or additional Schedule of Fees for applications, permits, licenses and approvals required by the Pennsylvania Sewage Facilities Act, as amended.

A. A fee in the sum of \$150.00 payable to the Township of Rush shall be paid to the Township Enforcement Officer at the time of making application for a single family dwelling unit with conventional sewage disposal system.

B. A fee in the sum of \$200.00 payable to the Township of Rush shall be paid to the Township Enforcement Officer at the time of making application for any sewage disposal system other than a single family dwelling unit. In the event that the actual cost to the Township shall exceed the fee paid by the applicant, then the applicant shall promptly pay such excess to the Township.

C. A fee in the sum of \$25.00 payable to the Township of Rush shall be paid to the Township Enforcement Officer at the time of making application for repairs to any sewage disposal system.

Section 3. The current Schedule of Fees adopted by the Supervisors of the Township of Rush shall be maintained, at all times, at the Office of the Township.

Section 4. Any person who shall violate the provisions of this Ordinance shall be guilty of a summary offense. Upon conviction such person shall be sentenced to pay a fine of not less than \$100.00 and no more than \$300.00 or in default thereof shall be committed to the County Jail for not more than 30 days.

Section 5. Any Ordinance or part of any Ordinance inconsistent with the provisions of this Ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 49 OF RUSH TOWNSHIP, SCHUYLKILL COUNTY, PENNSYLVANIA.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of the Township of Rush, Schuylkill County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same, as follows:

Section 1 of Ordinance No. 49 adopted January 5, 1976, requiring permits for the installation of sewage systems is amended to include the following:

"The permit referred to herein shall be required for all such sewage systems without limitation as to lot size."
