ORDINANCE NO. 57

AN ORDINANCE

SIGNIFYING THE INTENTION AND DESIRE OF THE MUNICIPAL AUTHORITIES OF THIS TOWNSHIP TO ORGANIZE AN AUTHORITY, JOINTLY, WITH ANOTHER MUNICIPALITY, UNDER PROVISIONS OF THE ACT OF ASSEMBLY APPROVED MAY 2, 1945, P.L. 382, AS AMENDED AND SUPPLEMENTED; SETTING FORTH AND AUTHORIZING EXECUTION OF ARTICLES OF INCORPORATION; APPOINTING AND FIXING THE TERMS OF THE FIRST MEMBERS TO PEPRESENT THIS TOWNSHIP ON THE BOARD OF SUCH AUTHORITY; AUTHORIZING ALL OTHER NECESSARY ACTION; AND REPEALING ALL INCONSISTENT ORDINANCES OF PARTS THEREOF.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Rush, Schuylkill County, Pennsylvania (the "Township"), and it is enacted and ordained, as follows:

Section 1. The Board of Supervisors of this Township signifies its intention and desire to organize an Authority, jointly, with a certain other municipality, under provisions of the Act of Assembly approved May 2, 1945, P.L. 382, as amended and supplemented, known as the "Municipality Authorities Act of 1945" (the "Authorities Act"), for the purpose of exercising any and all powers conferred by the Authorities Act.

The Authority shall be organized, jointly, by the Township of Rush and the Township of Ryan, both situate in Schuylkill County, Pennsylvania

Section 2. The Chairman or Vice Chairman of the Board of Superiors and Secretary, respectively, of this Township are authorized and directed to execute, in behalf of this Township, Articles of Incorporation for the Authority in the following form:

ARTICLES OF INCORPORATION

TO: THE SECRETARY OF THE COMMONWEALTH OF PENNSYLVANIA

In compliance with requirements of the Act of Assembly approved May 2, 1945, P.L. 382, known as the "Municipality Authorities Act", as amended and supplemented, and pursuant to Ordinances duly enacted by the municipal authorities of the Township of Rush and the Township of Ryan, both situate in Schuylkill County, Pennsylvania, expressing the intention and desire of the municipal authorities of said municipalities to organize an Authority, jointly, under provisions of said Act, said incorporating municipalities certify:

- 1. The name of the Authority is "RUSH-RYAN JOINT SEWER AUTHOR-
- 2. The Authority is formed under provisions of the Municipality Authorities Act.
- 3. Two Authorities have been organized under the Municipality Authorities Act, or under the Act of Assembly approved June 28, 1935, P.L. 463, as amended and supplemented, and are in existence in or for an incorporating municipality, and are as follows:
 - a) Rush Township Sewer Authority, Schuylkill County, Pennsylvania.

- b) Rush-Ryan-Delano Joint Sewer Authority, which is comprised in part, of the municipalities creating an Authority under these Articles, and the Township of Delano, Schuylkill County, Pennsylvania.
 - 4. The names of the incorporating municipalities are:
 - a. Township of Rush, Schuylkill County, Pennsylvania;
 - b. Township of Ryan, Schuylkill County, Pennsylvania.
- 5. The names and addresses of all of the municipal authorities of said incorporating municipalities are:

Section 3. The Chairman or Vice Chairman of the Board of Supervisors and Secretary, respectively, of this Township, acting jointly with appropriate officers of the other municipality set forth in Section 1 of this Ordinance, are authorized and directed to cause notice of the substance of this Ordinance, including the substance of the foregoing Articles of Incorporation, and of the proposed filing of such Articles of Incorporation, to be published as required by the Authorities Act.

Section 4. The Chairman or Vice Chairman of the Board of Supervisors and Secretary, respectively, of this Township, acting jointly with appropriate officers of the other municipality set forth in Section 1 of this Ordinance, are authorized and directed to file such Articles of Incorporation and the necessary Proofs of Publication with the Secretary of the Commonwealth of Pennsylvania and to do all other things necessary to effect the incorporation of such Authority, including payment of the required filing fee.

Section 5. The following named persons are appointed as the first members to represent this Township on the Board of such Authority:

Section 6. The enactment of this Ordinance is deemed necessary for the benefit of the preservation of the public health, peace, comfort and general welfare of and will increase the prosperity of citizens of this Township.

Section 7. All ordinances or parts of ordinances inconsistent herewith expressly are repealed.
