ORDINANCE NO. 102

AN ORDINANCE

LAYING OUT, ADOPTING AND TAKING OVER ONE PORTION OF A STREET OR ROAD IN THE HOMETOWN SECTION OF RUSH TOWNSHIP; FIXING THE LENGTHS, WIDTHS AND TERMINATION OF AND ORDAINING THE SAME TO BE A TOWNSHIP ROAD, THE SAME BEING A CONTINUATION OR EXTENSION OF A TOWNSHIP ROAD, TO WIT: SUNSET ROAD.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of Rush Township, Schuylkill County, Pennsylvania in accordance with the provisions of the Act of 1974, P.L. 1481, §15 (53 P.S. §6101) as amended, as follows:

Section 1. An extension of Sunset Road is hereby laid out, opened, adopted, taken over, ordained and named as a road of the Township of Rush, Schuylkill County;

Section 2. The dimensions of this extension of Sunset Road are as follows: From Sunset Road commencing on Pennsylvania State Highway Route 309, also known as Claremont Avenue, eastwardly to its intersection with Cumberland Avenue, THE SAID Cumberland Avenue also being a township street or road of the Township of Rush, the extension of Sunset Road being a street twenty-five (25') feet in width and three hundred (300') feet in length;

Section 3. The Township Supervisors hereby accept the deed of dedication executed by Anthony E. Flamini and Katherine H. Flamini, his wife, and Ermano Agosti and Diane Agosti, his wife, in favor of Rush Township dedicating the said section of Sunset Road to the Township as a township road;

Section 4. All prior Ordinances are hereby amended to reflect that all portions of the Township road known as Sunset Street or Sunset Road including this extension shall hereinafter be known as Sunset Street.

Section 5. Provisions of this Ordinance shall be severable if any of its provisions, or any part of the provisions shall be held to be unconstitutional, illegal or invalid under the laws of the State of Pennsylvania, in that only that provision or section shall be held to be unconstitutional, illegal or invalid. The validity of the remaining provisions of this Ordinance shall not be affected.

<u>Section 6</u>. All ordinances or parts thereof inconsistent with any of the provisions of this Ordinance are hereby repealed.
