RESOLUTION NO. 2023-09


WHEREAS, on February 16, 2023 the Rush Township Board of Supervisors adopted Ordinance No. 213 regulating Mobile Food Facilities/MFF's (commonly referred to as Food Trucks) and said Ordinance allows the Board to adopt by Resolution an application for permit form, an application for permit fee and to appoint an individual to administer the Ordinance;

NOW, THEREFORE, be it RESOLVED as follows:

1. The application form attached as Exhibit A shall be the official Township application form for a permit to operate a Mobile Food Facility/MFF.
2. The application fee for a permit to operate a Mobile Food Facility/MFF is hereby set at \$25.00 per day or \$150.00 annually.
3. The Township Zoning Officer is hereby appointed to receive applications, issue permits, decide whether permits shall be revoked, monitor compliance and file any necessary citations.


